Terms & Conditions

Please Note: By entering, Participants automatically accept its Terms & Conditions.

Terms & Conditions:

The QD Win Trolley Dash is promoted by QD Commercial Group Holdings Ltd (The Promoter), **Westbridge Lodge**, **Pendock Lane**, **Bradmore**, **Nottingham**, **NG11 6PQ**.

- The QD Trolley Dash will be available to enter at the tills by scanning a QD Reward Card across all 30 QD branches from 09.00hrs Monday 26th September 2022 until 16.00hrs Sunday 23rd October 2022.
- A Participant is defined as any person who agrees to enter the QD Trolley Dash for the chance to win the prize of being a 'QD Win Christmas' Trolley Dash Contestant. There will be 1 x trolley dash/winner per QD shop.
- Entry is open to all residents of the UK over the age of 18, excluding direct employees or agencies of QD Commercial Group Holdings Ltd or its group companies.
- To enter, customers are required to scan their QD Reward Card at the till when they make a purchase in any QD store.
- A Reward Card can be obtained for free by completing the app or application form available in any QD store.
- There is one entry per purchase/scan made in-store from 09.00hrs Monday 26th September 2022 until 16.00hrs Sunday 23rd October 2022. Multiple entries can be made by making multiple purchases.
- Customers who agree to enter the QD Trolley Dash will need to have their contact details registered with QD as
 part of their Reward Card application. Participants without email addresses will need to have a contact phone
 number registered instead. Provision of a valid email address or phone number constitutes acceptance of these
 associated Terms & Conditions.
- For entries to be valid, the correct email address or contact phone number must be provided during the Reward Card application or already registered with QD for customers with existing Reward Cards. Reward Card registrations which are incomplete, without all the required information, incomprehensible, or are not otherwise in accordance with these Terms & Conditions are invalid and will be discounted.
- The Promoter shall not bear any responsibility to notify Participants of incomplete entries or incorrect email addresses, or phone numbers supplied or entered.
- Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- The Promoter accepts no responsibility for entries which are lost, delayed, misdirected, incorrectly entered or which cannot be delivered or entered for any technical or other reason. Proof of purchase at QD is not proof of receipt of an entry.
- The closing date for entries is 16.00hrs on Sunday 23rd October 2022. Entries received outside of this time period will not be considered.

- The first randomly drawn Participant per QD store will win one 'QD Win Christmas Trolley Dash' prize.
- The Promoter reserves the right to temporarily or permanently cancel, terminate, modify, suspend or vary the rules and associated Terms & Conditions without prior notice.
- Winners will be drawn after Tuesday 25th October.
- All winners will be chosen at random from valid entries received in accordance with these Terms &
 Conditions. The draw to select winners will be performed by a random process in the presence of an
 independent observer.
- The QD Trolley Dash will be governed by English law and Participants to the Trolley Dash submit to the exclusive jurisdiction of the English courts.
- The Promoter's decision in relation to the selection of prize winners is final; no correspondence will be entered into regarding the outcome of this Trolley Dash.
- All winners will be notified by email (or via phone for non-email address holding Participants) on or before commencing 25th October 2022. Winners will have in total 7 working and weekend days to acknowledge receipt before the prize is automatically forfeited without compensation and another winner is chosen.
- If the winner rejects their prize, or the entry is invalid, or in breach of these Terms & Conditions, the winner's prize will be forfeited, and the Promoter shall be entitled to select another winner.
- Trolley Dashes will be held between 7th to 11th November 2022. They will take place between 18.00hrs to 19.00hrs Monday to Friday only, excluding weekends.

- Trolley Dash Contestants must be available to take part in the Trolley Dash at the store in which they entered and on the designated date and time they will be given when contacted. The designated date and time will be confirmed in writing/verbally when notifying the winner(s).
- The person chosen as the Trolley Dash Contestant is the only person allowed to complete the Trolley Dash, except in extenuating circumstances. Any extenuating circumstances should be submitted in writing for consideration. - The Promoter may, at its sole discretion, offer any Contestants unable to make the designated date the opportunity to take part on an alternative date or at a different QD store to suit both parties.
- If the Contestant is unable to accept the designated timings, alternative timings or conditions offered, the prize will automatically be forfeited without compensation to the Contestant.
- By agreeing to enter the QD Trolley Dash, Participants/Contestants are aware of the nature of the Trolley
 Dash and the associated physical risks involved. The Participant agrees that he/she is physically capable of
 participating in the Trolley Dash and agrees to be solely responsible for their actions if they are drawn as a
 Contestant.
- Except in the case of death or personal injury arising from its negligence, or in respect of fraud, and so far, as is permitted by law, The Promoter does not accept any responsibility for case of death, any loss, injury or damage suffered by any Contestant as a result of their taking part in the Trolley Dash. The Promoter shall not be liable for any recourse or claims as a result of any physical, mental, or other loss or damage suffered due to the Contestant's involvement in the Trolley Dash.
- The Promoter reserves the right to refuse any Contestant to participate in a Trolley Dash if they suspect the
 Contestant to be under the influence of alcohol, illegal substances or other reasons unable/unfit to take part.
 The decision of the Promoter will be final, and the prize will automatically be forfeited without compensation
 to the Contestant.
- The Promoter reserves the right to verify the eligibility (including but not limited to requesting written proof of age of any winner(s) and identity of any winner before the prize of the Trolley Dash is given to any Participant.
- The Trolley Dash prize consists of a/one 1-minute (60 seconds) Trolley Dash. This entitles the Contestant to
 free shopping for 1 minute in the QD store where they entered and at the time and date specified by the
 Promoter.
- The Trolley Dash will take place in the designated store's Christmas department only (including both food, seasonal food and non-food related). The Contestant will be informed of the rules, including any excluded areas/aisles or products before the time commences. **Exclusions alcohol and fireworks will not be included.**
- In the event of any dispute regarding the rules, conduct or the results of the Trolley Dash, the decision of the Promoter will be final and binding.
- Within the allotted time, the Contestant will place as many items as possible in their trolley.
- The Contestant may take a maximum of two of any particular item(s).
- The Contestant must start the Trolley Dash at the designated start point, stay within designated aisles, and finish at the designated checkout point once the 1 minute has elapsed.
- The Contestant will be alerted after a 30-second interval has elapsed.
- The Contestant can fill one trolley only. All items must be placed inside the shopping trolley to be included in the final prize.
- Products collected during the Trolley Dash cannot be exchanged for replacement products, cash, or credit equivalent.
- Any items that are broken or damaged by the Contestant during the Trolley Dash will not be substituted for an undamaged one.
- Contestants are encouraged to invite along close family/friends to watch the Trolley Dash, there will be a maximum of 5 persons allowed and must watch from a designated area so as not to impede on the Trolley Dash.
